Minutes of the Hayle Town Council Meeting held at the Hayle Community Centre, Hayle on Thursday 15 August 2013 commencing at 7.15pm with a **Public Participation Session**.

7.15PM PUBLIC PARTICIPATION SESSION

David Dawe of Treview, Trelissick Road, detailed his objections to the planning application regarding his neighbour, 52 Trelissick Road. These were that the proposal was in a conservation zone, it was dense and not in keeping with the area. He had concerns regarding the deal with the Tree Officer and said that the yew tree was his. The proposed building was only three metres from a shared boundary and that at six metres tall it would shadow the bungalow next door.

Richard Brown, a neighbour who lived adjacent to 52 Trelissick Road also voiced his objections. He considered the proposal to be an overdevelopment in the area which would exceed the density number and it would be on a blind bend. He also said that the trees, which had been marked for felling, were appreciated by the residents of the street.

Wendy Thomas of 59 Trellissick Road stated that she was not objecting to the development of the site per se, but to the size and style of the development in this application.

Jon Pender spoke in support of the application regarding 52 Trelissick Road. He described the existing building as a 1960s single storey bungalow and explained that the proposed build was a modern dormer bungalow design. He stated that Cornwall Council had only refused on account of the trees and claimed that this meant they had accepted the plans regarding highways, style, development etc. He said that the applicants had worked with Cornwall Council regarding the development and had met all its earlier concerns.

In response to Mr Pender, Wendy Thomas stated that the proposed building was certainly not a dormer bungalow and it was also pointed out that Cornwall Council actually had several other concerns.
