7. 15PM PUBLIC PARTICIPATION SESSION

The following residents of Angarrack all presented objections to the Council regarding planning application PA16/03519: - Gail Willis, Marilyn Kelland, Russel Clarke, Geoff Pooley, Carol Clarke, and Michael Witheridge. Each resident spoke in turn raising different concerns and highlighting potential issues, including ecology, traffic, retail capacity, the Neighbourhood Plan and the flood risk, relating to the Cranford application.

Jacqueline Richards spoke in support of planning application PA16/04933. She explained that this revised application had been amended taking into account and addressing all of the concerns previously raised by the Town Council and the planning officer and confirmed that this design would not negatively impact on her neighbours.

Charles Green, agent, and Sarah Park, owner, both addressed the Council and spoke in support of planning application PA16/04344, explaining that they had to build on and enhance the Georgian characteristics of the building.

Paul Pellegrinetti repeated his previous complaint regarding the vandalism and the general poor condition of the Train Station area and bridge. He reiterated that it needed to be sorted.
