#### 192 TO CONSIDER THE RESPONSE FROM RUSSELL DODGE TO HAYLE TOWN COUNCIL'S COMMUNICATION REGARDING THE FORMER HAWKINS MOTORS SITE (AS PER THE RESOLUTION IN MINUTE 168, 17 DECEMBER 2015)

There was a discussion regarding the correct procedure that would have to be followed by all parties concerned if amendments to the S106 were required to avoid breaching the current S106 and/or to remedy current breaches, if any.

It was noted that the current S106 did not allow Hayle Town Council to sell the site and that the land in question should have been transferred to the town council before the construction of the housing development had begun.

It was agreed that further detailed legal and planning information regarding the S106 was needed before any further negotiations with the owners of the former Hawkins Motors site could be undertaken.

**It was resolved** to convene a meeting between the Mayor, Deputy Mayor, Chairmen of the Resource and Amenities Committees, Jeremy Content, Principal Development Officer, and a Cornwall Council planning lawyer to explore the different options regarding the S106.

**It was resolved** to write a holding letter to Russell Dodge informing him that the town council would be seeking planning and legal advice regarding the matter of the S106.
