Jeremy Content  Notes from Assistant Clerk after phone conversation with Jeremy Content 30/10/13: I have just spoken to Jeremy Content who is the CC planning officer responsible for this application. Apparently this will be a waste transfer site for builders' waste and will not be open to the general public for waste disposal. It will deal with timber, rubble and plastics used in construction. Currently there are deliveries to the site, if this goes ahead it is expected that builders will take their waste there, perhaps then to fill up with newly purchased goods, and of course there will be vehicles arriving to take away the waste.
