# 25 CHAIRMAN'S ANNOUNCEMENTS (FOR INFORMATION ONLY)

The Clerk confirmed that Cornwall Council election had not been called for the most recent vacancy (Councillor Farrar's position) and therefore the Clerk would begin the co-option process to fill this vacancy and the existing on North Ward. It was also reported that Councillor Darcy had been disqualified as he had not attended a formal meeting since Thursday 9 January 2020.

#### 26 TO RECEIVE APOLOGIES

Apologies were received from Councillor's Mims and Nidds. The Mayor explained that Councillor's Mims and Nidds absence was due to their health issues.

Councillors Coad and Pollard declared an interest in agenda item 10 (minute 33 refers) and made the following statement: - 'In commenting on these issues/applications I should make it clear that my comments are based on the information currently available and do not commit me to taking the same position if the matter is discussed at the Cornwall Council Planning Committee and full information is available.'

# **30** TO ADOPT THE SCHEDULE OF MEETINGS 2020/2021

It was resolved to adopt the schedule of meetings for current year.

It was suggested that there was a need for the Resource Committee to meet earlier than November. The Clerk advised that she will discuss it with the chair of Resource, Councillor Capper, and follow up on this matter.

#### 32 CLERK'S REPORT/CORRESPONDENCE/CONSULTATIONS/MEETINGS a) To consider the draft planting scheme for Harbour View.

**It was resolved** to object to the planting of more trees as the area has recently benefitted from additional trees, landscaping and improvements through the Green Infrastructure 4 Growth programme and the remaining open space is used as a greenspace and play/exercise field by residents.

- b) To consider the two recent requests for yellow lines and associated signage to determine whether they should be submitted to the Community Network Panel as potential Highway Scheme:
- (i) Rear of Chapel Terrace, Foundry
- (ii) Markets Street, Copperhouse, between Down the Line Surf Shop and Chandler's Fish and Chip Shop

**It was resolved** to support both requests for yellow lines and to submit the request to the Community Network Panel as potential Highway Scheme.

c) To consider the request from a local author to highlight a tree on King George V Memorial Walk, which she has written about in her book 'The Wise Old Tree' with appropriate signage

The Clerk gave Councillors a brief summary of her discussion with the gardener and that she confirmed that she was happy for the tree to be highlighted in the book.

It was resolved to support the request from the book author and to allow the author to provide the signage. The signage, however, will have to be approved by the Council prior to the installation.

d) To retrospectively confirm the arrangements for the Swimming Pool season 2020, following the Governments announcements about the opening of openair pools, 9 July 2020

The Clerk gave Councillors a verbal report on the arrangements for the Swimming Pool opening on the 25 July.

Councillor Roden raised his concerns against opening of the Swimming Pool and requested for it to be recorded in the minutes.

It was resolved to note the arrangements and confirm the Swimming Pool season 2020.
