#### R1 TO ELECT A CHAIRMAN AND VICE-CHAIRMAN FOR 2021-2022

# R4 TO APPROVE THE MINUTES OF THE RESOURCE COMMITTEE MEETING 11 MARCH 2021

# R7 TO APPROVE THE RELEASE OF THE 1ST QUARTERLY PAYMENT TO HAYLE YOUTH PROJECT NOTING A CHANGE IN OPERATIONS DUE TO COVID-19

Members discussed that the money had been allocated to provide extra capacity to the service that is already being provided and stressed the importance of providing additional services.

**It was resolved to** NOTE the change in operations due to covid-19 and approve the release of the 1<sup>st</sup> quarterly payment as soon as Hayle Youth Project had assured and demonstrated an increase in provision of services.

# R8 TO NOTE THE FINANCIAL QUARTERLY REPORT FOR THE PERIOD 1 APRIL – 30 JUNE 2021 INC.

It was resolved to NOTE the financial quarterly report with thanks from the committee.

# R9 TO REVIEW AND ADOPT THE DRAFT INVESTMENT STRATEGY POLICY AS PER THE INTERNAL AUDITOR'S RECOMMENDATION

Members discussed the request from the internal auditor to review the policy highlighting the importance of ethical investment. A discussion followed suggesting researching the ethical investment policies adopted by other local councils. Members agreed that being prudent and ethical was an important thread required throughout the document and the policy should be amended to reflect this.

It was resolved to adopt the draft investment strategy policy with the above amendments added and approved by the committee.

R10 TO NOTE THE OUTCOME OF THE INSURANCE SETTLEMENT CLAIM RELATING TO THE INCIDENT AT HAYLE COMMUNITY CENTRE ON 8 JULY 2021

It was resolved to NOTE the outcome of the insurance settlement claim.

R11 TO NOTE A REFUND OF £4,795.40 FROM CORNWALL COUNCIL FOR OVERPAYMENT FOR NON-DOMESTIC RATES FOR TOILETS AT FOUNDRY SQUARE, RIVIERE TOWANS AND COMMERCIAL ROAD, BACKDATED TO 1 APRIL 2020

Members noted the refund and agreed for the money to go into general reserves. A discussion followed where the need for seating at the recreation ground was highlighted as being beneficial for the community which was agreed by all members.

**It was resolved** to NOTE the refund and members agreed to use the money towards the purchase of three picnic benches for Hayle Recreation Ground, informing the Amenities Committee of the intentions.
