### 124 CONSULTATION

Members discussed the Cornwall Transport Plan and agreed the need to reduce traffic through Hayle, as well as the need for separate bicycle trails. They also agreed that the plan does not necessarily fit Hayle as the policies and strategies do not apply to such a unique town. Members discussed that there is not the room for cycle lanes in Hayle, but safer cycling is needed to encourage more cycling.

The Town Clerk displayed a slideshow of the survey for Councillors and the details of how to respond were discussed. It was agreed by members that the survey is not specific enough, and that some initiatives could do more harm than good. They also agreed that the survey is too generic and does not consider individual needs, and is too vague and aspirational. The impact cannot be assessed until the specifics have been made clear.

As it stands, members cannot see how the policies will benefit Hayle, or see how they will be interpreted or implemented. Members also agreed to stress the need for a Tolroy Junction, as they all believe this would have the most positive impact on the town.

**It was resolved** to respond as a Council with the Town Clerk to prepare the survey response as agreed by Councillors.
