118 CHAIRMAN'S ANNOUNCEMENTS (For Information Only)

The Mayor informed members that the Hayle Vision Consultation had been completed and that the results would be presented by the consultants at a Town Team meeting being held on Wednesday 9 November, 7pm at Hayle Day Care Centre.

Members asked for information regarding the arrangements for the forthcoming Remembrance Service and Parade being held on Sunday 13 November 2022. It was agreed that details would be circulated the following day.

122 TO DISCUSS MATTERS WHICH WERE RAISED DURING PUBLIC PARTICIPATION

123 GUEST PRESENTATION: AMY FINDLATER, FUNDING & DEVELOPMENT LEAD AT DISABILITY CORNWALL TO DISCUSS THE PROPOSAL FOR THE WEST CORNWALL INCLUSION AND WELLBEING CENTRE

Amy Findlater and Jane Johnson MBE introduced themselves to councillors and displayed their presentation on the screen.

Jane explained that Disability Cornwall and IoS is a registered charity, currently in its 25th year of providing services and support to people of all ages, with a long-term health condition or disability, their carers and families. 23% of Cornwall's population have a long-term health condition/disability, this could be anything from Autism, sight loss, hearing loss, MS, a spinal injury or hidden disability such as Crohn's disease or ill mental health (census 2011). She explained that they are also the umbrella organisation for all 10 local disability organisations in the county and the system lead for disability and dementia in the voluntary and community sector (VCSE).

Jane informed members that the organisation has always been Hayle based, but in the last two years they have grown in terms of services and staff and need not only significantly more office space, but meeting rooms, conference facility and more, to accommodate future needs for how the wider system is changing to ensure they can fully engage with it. She explained that their current location on an industrial estate cannot accommodate the growing staffing levels required, and also that the industrial estate brings health and safety considerations for disabled people to access and if they do, the external environment presents risks. Jane said that due to this they need ground floor level access buildings so they can be adapted to be fully accessible and inclusive for stakeholders to use. She then highlighted the potential benefits for Hayle if the proposal is accepted:

- Mobility Provider in the town
- Funding to host Vaccination clinics with staff on site to support (requested by Public Health)
- Public Health have expressed an interest that if there is a wellbeing centre on site through disAbility Cornwall, to be able to host screening units (Breast screening etc.) on the grounds
- Access to the first of its kind in county, a fully accessible centre, with all services open to all residents
- Partners to have on site presence and use of buildings
- Reputation as an inclusive, wellbeing facility for Hayle and West Cornwall which will generate good will, funding sponsorships and endorsements
- Use of Every Customer Counts to make Hayle the first Cornish Town to embrace accessibility, this service is about to be utilised with in Investors in People nationally and would put Hayle on the map
- VCSE organisation from the area represented at Integrated Care Board
- Further employment opportunities for residents

- Hayle businesses to gain their share of the 'Purple Pound' estimated to be over £274b nationally
- Having the nationally recognised Disabled Peoples Organisation of Cornwall & IoS located in Hayle

Jane and Amy thanked members for listening to the proposal and welcomed any advice and discussion.

The Mayor asked about the type of space the organisation is looking for, and members made some suggestions including the Beach Hut, which Cornwall Council (CC) has put forward for consultation, to be considered during this meeting.

124 REPORTS OF OTHER COMMITTEES FOR APPROVAL

a) To receive the report of the Amenities Committee meeting 8 September 2022 and 13 October 2022

It was resolved to receive the report from the Amenities Committee meeting 8 September 2022 and 13 October 2022 so that actions could be carried out.

125 REPORTS FROM OTHER BODIES/WORKING PARTIES/EVENTS

a) To receive a report from the Projects and Events Officer

The report prepared by the Projects and Events Officer displayed on the projector (*see attached Appendix A*).

She explained to members:

- The relaunch of the Town Team would be on Wednesday 9 November at 7pm in Hayle Day Care Centre. The meeting will be hosted by the consultants that carried out the Hayle Vision Consultation and there would be opportunity for all attendees to get involved.
- The bicentenary of Passmore Edwards will be commemorated with a variety of events around his birthday on 24 March. A local sub-committee will meet to decide how Hayle will celebrate.
- The coronation of King Charles III will be on 6 May 2023. Would the council like to commemorate the event?
- A ten-week theatre production would like to come to Hayle in the summer of 2023. Would there be a suitable location and investment?
- That she had a attended an online conference about the use of green spaces in local communities and how to make them more accessible to everyone. She would be following up on ideas presented.
- A LinkedIn page had been set up to engage more with the local business community.
- The Discover App had been updated and was showing signs of improved use.

Members discussed the Coronation and the need to budget for an event, they considered potential locations for tree planting and possible names for the former Hawkins Motors site.

It was agreed to take the matter to the Town Team for consideration.

a) Hayle Harbour Update

A report had been received from the Harbourmaster, which had been circulated prior to the meeting and was displayed on the projector.

Councillors raised concerns about a large crack that had appeared along the harbour wall at South Quay and discussed who would be responsible for the maintenance.

It was resolved to NOTE the report.

- b) Cornwall Council Update
 - (i) To receive reports from Cornwall Councillors Channon and Pascoe

CC Councillor Channon explained to members the report he had prepared which had been circulated prior to the meeting. It was displayed on the projector and subsequently NOTED.

CC Councillor Pascoe had nothing to report.

c) To receive a general update from Tri-Service Officer, Adrian Hart, on local issues

The Mayor told members that the Tri-Service Officer had sent his apologies and had prepared a report which had been circulated prior to the meeting and was displayed on the projector and subsequently NOTED.

Members discussed that they would like the report to make clear the exact service that is being received by Hayle, and that a regular police report would be beneficial.

Following the guest presentation made by DisAbility Cornwall, members agreed that the Beach Hut would be a suitable location for the requirements described.

CC Councillor Channon offered to assist the organization in its negotiations with CC.

It was resolved to fully support DisAbility Cornwall's proposal and to put them in contact with Cornwall Council regarding the Beach Hut.

c) To note the Legacy Sculpture offered to the Community by the Who Dares Works Project and decide on a location for its display

The Senior Administration Officer explained the design of the sculpture to members and suitable location was discussed.

It was resolved to display the sculpture at the former Hawken's site and that it needs to be incorporated into the design by the landscape architects.
