Hayle Community Action Group

The next meeting of HCAG is arranged for **7pm** on **Wednesday 13th September** at **The Old Foundry Chapel.** At the last meeting Graham from Mei Loci presented the draft Master plan. The master plan will be circulated to members once it has been received. The group will also be exploring the other kinds of more short term projects that can be taken forward at their next meeting.

This will coincide with going into schools with Graham and Nina from Mei Loci to explore connectivity as part of the master plan in order to demonstrate how the views of children and young people (gathered during the Vision for Hayle work) have been taken forward.

Hayle Health and Wellbeing Festival/Community Showcase





Hayle Health and Wellbeing Festival is planned for the 23rd – 24th September. A range of local groups and businesses are offering free taster sessions, including sound baths, Tai Chi and Qi Gong, yoga, wild swims, craft activities and so on. Hayle Health and Wellbeing Festival is an event for all. Most of the activities take place on Saturday 23rd September with some taking place on Sunday 24th. The main event site is Hayle Academy with things also going on at Paddy's Mill, Sandy Acres and North Quay. The activities are organised into four themes: Connect, Move, Eat and Explore. All of the activities are being provided for free except the silent disco on Saturday evening which is being charged at £3 and a meal to launch the festival at Cove Café on Friday 22nd.

On Sunday 24th September we will also be holding the Mayor's Fundraiser Walk and Roll for St Julia's Hospice on KGVMW. The event will end at The Rec with some activities and entertainment from local choirs, including a Makaton choir.

People can pre-book the activities using a paper or online form as there will be maximum numbers of attendees. It will also give an indication of numbers for the event. Refreshments are being provided by Foundry Food and the WI



at Hayle Academy and Be Kind at Paddy's Mill which is relocating for the day.

Hayle Day Care Centre have agreed for us to use their minibus as a shuttle between sites if we can get a driver (under 70) with a D1 licence that will be covered by their insurance.

Some sponsorship money has been obtained from Aspects Holidays which will cover some of the cost of First Aid cover. Further sponsorship is being sought to cover the remainder and the cost of petrol. It was hoped that enough sponsorship would be found to cover the cost of a BSL signer as Saturday 23rd is International Day of Sign Languages but at the moment this looks unlikely.

Bodriggy Surgery has agreed to send a text message out to their patient list to advertise the festival. Their staff, especially the social prescriber have been incredibly helpful.

The festival will be followed up with monthly sessions that carry forward the festival's essence, focusing on the four core themes of Connect, Move, Explore, and Eat. The first of these sessions will take place in October, beginning with an insightful online talk about "Health, Wellbeing, and Seals." Sue Sayer MBE from the Seal Research Trust will share her decades of observations on seal behavior, offering an intriguing perspective on the links between their world and ours. This session, will be suitable for anyone over 12, invites schools, colleges, nature lovers, and businesses to come together and explore the interconnectedness of our environment.

Other organisations have shown an interest in being involved which is really positive. Suggestions for this are gratefully received.

The council now has a large database of contacts which can be used for future activities.

Help from members over the course of the two days would be incredibly helpful. Get in touch if you are able to offer some time to help, particularly on Saturday but also Sunday. There are plenty of roles that need volunteers (especially if anyone has a licence to drive the minibus).

The Sensory Trust

A message from The Sensory Trust:

Sensory Trust is planning a project about climate change and restorative action called the Language of Repair and we would love for Hayle Town Council and King George V Memorial Walk to be a part of it. The project will demonstrate a new approach that focuses on the water cycle rather than carbon cycle and which, as a Sensory Trust project, is inclusive in its approach, activities, content and language. We are excited by the possibilities!

Why water? Typically, climate change has a dominant narrative about carbon emissions and information is often complex and hard to engage with. This project responds to exciting new research from experts in Australia, Europe and USA who have highlighted that addressing water vapour and the water cycle may be a more effective and affordable way to tackle climate change than focussing solely on carbon.

Actions can be as simple as adding mulch to soil and can make a difference much faster than other approaches. Meaningful water cycle interventions can also be implemented anywhere and at any scale, empowering individuals and communities who might not be able to implement net zero carbon technological solutions such as solar panels.

The aim of the project is for people to learn how to take direct action while understanding more about climate change and the vital importance of water. It is based on collaborative working and we are keen to work with blind and partially sighted people, people who are D/deaf and people with inclusive communication needs to develop activities and accompanying resources that can be shared though community events, at workshops and

online, and demonstrated at 'climate repair cafes'. We will also use plain language to reduce the complexity of climate science and create narratives that are personally meaningful and engaging.

Project activities will take place over the next 4 years across England and Scotland with a focus in Cornwall, Liverpool, London and Edinburgh.

The Sensory Trust would really like Hayle Town Council to be a part of the project and are hoping HTC would be interested in King George V Memorial Walk being a site where the project could run a few workshops and/or 'climate repair cafes'. The workshops would involve community members and groups developing activities and resources for small interventions such as mini-meadows and mini-forests, or trying out simple techniques for demonstrating and monitoring the role of water in climate repair such as exploring soil temperature and water flow.

At this stage it would involve us writing a letter of support for their funding application which the Projects and Events Officer can do if the council is in support.

Funding

Shared Prosperity Fund

Connecting Communities: Community Organisation Fund

An application was made to the Connecting Communities Fund for the relocation project at the end of July. The outcome of the application will be sent to us in October.

CIL Funding

The expression of interest for CIL funding for the Recreation Ground was passed through to the next stage of application. We will be making the full application by 20th October for the maximum available of £100,000.

National Lottery Funding: Heritage Fund


An Expression of Interest will be submitted to the National Lottery Fund (Heritage) to pay for work to improve the Plantation, Millpond and possibly KGVMW. Once an EOI has been accepted and successful, we will have 12 months to complete the full application. This fund awards up to £10 million. This will be a large application and it will be useful to involve other key organisations in the town as the key focus for the fund is to bring heritage to more people so it won't just be a case of making repairs to the sites but also looking at how to make the most of the heritage of the sites. This will take some time to put together.

We are really looking forward to offering more opportunities to our local community which will hopefully give a little boost to their health and wellbeing.

HM September report to the Town Council

South Quay

I am chasing Duchy Civils who following a site visit in July have agreed to quote for the necessary plans and drawings that are required by Historic England to enable the repair to the South quay wall. When this is received, I will be able to take the project forward.

Youth Problems

I was expecting the problems we experienced with youths during the summer holidays to be a repeat of last year, however due to the unsettled weather there has only been a few isolated incidents and in general when challenged those involved have responded and done as asked by harbour staff.

At the July Hayle Harbour Advisory committee meeting the problems experienced around the harbour by youths were discussed in great detail and a proposal was tabled that we ask the schools for a representative to sit on the HHAC which would then provide a direct route enabling the harbour authority to engage with students and explain the dangers of a working harbour also to encourage more responsible behaviour through some kind of student involvement on the harbour yet to be determined.

Maxine Hardy agreed to take this forward and contacted the Headteacher at Hayle Academy.

Thank you for your email and apologies for not responding sooner – it was a very busy end of term!

We would very much be interested in working together on safety around the harbour area.

Vessel sinking

A vessel moored on Penpol bank sank this weekend a result of the vessels prop becoming caught in its own mooring line and prevented it from floating on which was an exceptionally high tide. The owner attended but did not require any assistance from the Harbour authority to refloat the vessel.

Dredging

To ensure the Safety of beach goers in the vicinity of the North quay foreshore no dredging has been undertaken during the summer months. Several fishermen and leisure users have expressed their concerns about the current state of the channel therefore I would expect dredging to recommence later this month.

Caravans

Rubbish and faeces were seen by our maintenance person beside the caravans opposite the wave hub buildings. He took some photos, and I made a complaint to CC highways as this is an adopted road. CC passed this onto Mark Ward community Environment Enforcement officer who I am now dealing with.

Good morning,

I have heard back from the Complex Needs Service and they have let me know that the case regarding these last 2 caravans went to court and that the occupier lost the case. He was supposed to be moved on by 3rd July under his own steam; this does not appear to have happened as yet, so is going to find out what is happening and get back to me later.

Fishermen

I received a complaint from a member of the public regarding the state of Carnsew quay and the hazards that unregulated storage of fishing equipment which was strewn over the area presented to members of the public. I investigated and must agree that the area was far from tidy. I contacted the chair of the fishermen's association informing him of the complaint who assured me he knew who the culprit was and would deal with it.

Stone facing

The sea wall at the harbour office is sheet piled and stone faced. It has become evident that the stone was not tied into the sheet piling as it has collapsed in one area. Initially until this can be addressed

temporary barriers were put in place to keep the public of the grass. However, these were constantly being blown over, so we have installed some wooden posts with a rope line though them and signage that the grass verge is unstable this looks much tidier and has a nautical look.

I am thinking that something similar on South quay opposite the viaduct but on a larger scale may work, which could be a cost-effective solution to providing edge protection on this part of the quay. When passing the harbour office please have a look at what has been done as I would value the opinion of councillors as to whether HTC think this could work on South quay.

North Quay Development

After our recent visit to HTC meeting in July, I would firstly like to respond to members questions that were asked when present:

"We understood that planning requirements stated that the car park will be returned to dunes?" As discussed in the previous meeting that there are plans to restore the area back to dunes using North Quay's very own aggregate, a more aesthetic route. The timeframe for restoration to dunes will most probably be between 4-5 years, this will be one of the last phases of build.

"Is there a connection between the North Quay development site and the former R&J's development site? Lorries have been seen travelling from one to the other."

There is no connection between R&J's development. R&J's have a agreement with one of our contractors PB Services to hold material within their company and store equipment if needed.

"Will the access road to the chalets at Harvey's Towans remain, even after the dunes are restored. Do they have a legal right of access?"

For the duration of the time that there are chalets/accommodation within Harvey Towans, there will be access roads to enable residents to get too and from their accommodations/chalets safely and securely. As a company, we hold the legal right of access for accommodation within Harvey Towans but do not plan on removing access/parking for those residing there currently.

"We understand that the areas around the building site are to be reinstated. Can you bring plans back to HTC for us to check if they are appropriate?"

We can certainly bring plans for HTC when we are closer to the timeframe of restoration around North Quay. We are currently quite far from this as build is still progressing but once build has developed, I will most definitely bring this along for all to view. I have also planned to sit with a Landscape Architect in the next couple of months with plans on how to integrate wildlife and greenery in and around site as we progress to build.

We have had progress with build over the last couple of months at North Quay, with exiting plans starting to form within Riviera Fields which looks to bring a lot of vibrancy and life to Hayle. The inspiration within this phase is integrated with a natural & easy-living lifestyle, with buildings that form and fit seamlessly within the beautiful, aligned hills that roll at the top of the site. — E.Wright

This application has come back to you due to an 'administrative error' in that HTC and the Local member were not invited to speak on the original date (26th June). This in itself does not inspire confidence that the system is being fair and reasonable, and in this particular area which was supposed to be part of the 'stalled' Hayle Growth Area the implications for development are now serious due to the lack of committed facilities and improvements that the HGA was supposed to provide. This is a complicated arena at present and requires members to be fully briefed on the implications of the HGA and its effect on Hayle without the improvements and the resultant impact on the dreadful highways situation we are faced with.

In fact a previous nearby recent application (Viaduct hill) was in a similar situation and subject to voiced concerns by HTC and the local member, and indeed a site visit was suggested (by myself) which would have made clear to members the real situation on the ground. CC planning declined to allow this to happen even though members comments at the meeting confirmed there was considerable confusion regarding the planning situation in the area.

HTC are now going to have a full briefing on the HGA from planning, but that will not be until September, therefore it seems logical that the committee needs to have this (and a site visit) before any decisions are made.

Just to be clear on this HTC and myself are not against the principle of the HGA (as was) but as the situation has now changed out of all proportions it is imperative that anyone involved in planning decisions for this area need to be fully briefed and also familiar with the situation.

I therefore suggest this meeting requests a Site visit and briefing in order to fully understand the current and ongoing position.

This is only a 'compact' view of the situation but I will be happy to expand on all aspects and answer individual questions. At a recent planning training briefing it was confirmed by CC staff that site visits were an important feature of the planning system and should be used when needed to ensure members are correctly briefed and aware of ongoing implications.
