#### 95 TO RECEIVE A PRESENTATION ON THE HAYLE MASTERPLAN PRESENTATION FROM GRAHAM PRENTICE, OF MEI LOCI, AND, IF APPROPRIATE, RESOLVE TO SUPPORT THE MASTERPLAN

Graham Prentice introduced himself and displayed a presentation on the projector (*see attached Appendix A*) which included:

- An introduction to Hayle
- Background to the project
- Hayle Vision Consultation: The consultation themes were developed to continue and build on the work started by the Hayle Neighbourhood Plan (2018), Hayle Growth Area

   Concept Plan (October 2020) and the Welcome Back Fund/Covid Recovery Plan (January 2022). The aim of our consultation was to focus discussions on what could happen next, what people would like to see happen in their town and from their ideas develop a vision for Hayle that results in real projects.
- Themes: key ideas that inform the Masterplan for Hayle: Movement and travel, place and space, natural environment, community, leisure and recreation, economy and work.
- Developing the Masterplan
- Existing sites and Proposals for each

Graham showed examples of the existing features of the town and described the aims of the Masterplan, he displayed images depicting existing sites around the town and the proposed improvements.

Members raised some questions regarding traffic calming measures. Overall, they agreed that although the project was ambitious, they thought that it was amazing and really liked it.

CC Councillor Pascoe asked to speak.

It was resolved to allow CC Councillor Pascoe to speak.

CC Councillor Pascoe explained that since the King George V Memorial Walk (KGVMW) had been closed to traffic, he had received reports that bicycles were becoming more of a problem than cars, He was concerned that this could happen in other areas of Hayle, if further traffic calming measures were implemented.

It was resolved to fully support the Masterplan, subject to amendments.

Graham Prentice told Members that he was happy to come back and update the council on this ever evolving process and left the meeting at 8.20pm,
