#### **63 TO RECEIVE APOLOGIES**

Apologies were received from Councillors Channon and Cocks.

#### **64 TO RECEIVE DECLARATIONS OF INTEREST AND REQUESTS FOR DISPENSATIONS**

Councillors Coad and Pollard declared an interest in agenda item 3a (Minute 65a refers) and made the following statement: - 'In commenting on these applications I should make it clear that my comments are based on the information currently available and do not commit me to taking the same position if the matter is discussed at the Cornwall Council Planning Committee and full information is available.'

- b) To note the results of previous applications

**It was resolved** to note the results of previous applications.

It was noted that the Loggans Moor application, PA17/01250, was going to appeal. The Clerk mentioned that the Chairman of Hayle Neighbourhood Plan Steering Group, John Bennett, had offered to write a letter of objection from the group, echoing the comments submitted by the town council. Councillors agreed that this would be useful.

- c) To nominate a councillor to attend the Cornwall Council Strategic Planning Committee to represent the town council’s views on Application PA/17/02388; Erection of two dwellings - Land East of 1 Harbour View, Hayle TR27 4LB

**It was resolved** that the Mayor, Councillor Nick Farrar, would attend the meeting and represent the council’s views.

**66 TO CONSIDER PRESENTING TOWN PLATES TO THE FORMER MAYORS NO LONGER SERVING ON THE TOWN COUNCIL**

There was a lengthy discussion about who and what actions merited receiving a town plate and members considered that a protocol should be drafted.

Councillors were also reminded that some previous Mayors had already received a town plate in recognition of their long service to the council.

**It was resolved** that the Clerk should source glass/crystal presentation gifts, with the Hayle Town Council logo, to be presented to all former Mayors upon leaving the council from this point onwards.

**It was further** resolved that the Clerk drafts a protocol which establishes the criteria for being selected to receive a town plate.

The subject of town plates led to the subject of nominating members of the community who should be considered to receive plates in the near future

**It was resolved** to exclude the press and public for the following items, in accordance with Standing Order 1c, due to the confidential nature of the business.
